

# The Williamsburg Township Board of Trustees

**January 9, 2006**

The Williamsburg Township Board of Trustees met on Monday January 9, 2006 to transact business. Chairman Henning called the meeting to order at 7:30 PM, and all joined in the Pledge of Allegiance to the Flag. James Danbury, Bari Henning and Jim Taylor answered the roll call. Also present were Fiscal Officer, Gregory W. Carson, Yvonne Malott, Deputy John Schaeffer and Earl Whiteman.

Mr. Carson reported that he did not have the minutes complete yet because of year end reporting and he said that he would have them typed for the next meeting. Mr. Carson presented a financial report, including a comprehensive account of expenditures and receipts and the trustees accepted it.

### **Sheriff Report**

Deputy Schaeffer gave a copy of the number of runs for December. He reported that there have been several burglaries on Dela Palma Road that they are still looking into. He said that there has been a string of mailbox bashings around the township and Brown County also. Mr. Taylor said that someone from the county talked to him about the amateur radio problems on Alexander Lane and he said that he has some contact information of people to get in touch with. He said that he is going to write some letters about the problems. Mrs. Malott gave Mr. Taylor the list of addresses of the neighbors who have signed complaints about the problem.

### **Cemetery & Maintenance Report**

Mr. Whiteman said that there were 85 burials in 2005. He said that they are planning to pour the sidewalks at the township hall tomorrow and they will birm the sidewalks this spring. Mr. Whiteman said that Bryon Wilson was buried as an indigent as a request from the owner of the handicap group home and the township provided the grave and open/close. He was 43 years old and buried in Lot 3 Section 131 Grave 8.

### **Zoning Report**

Mrs. Malott presented a zoning report. Mrs. Malott said that the zoning inspector in the Village of Newtown reported that Joe Berger bought a two car garage in Newtown and they are waiting for him to do something, because the garage is in a residential district and not a business district. Mrs. Malott said that several of the mowers from Mr. Berger's business have been moved to his home in Williamsburg Township and she is watching it, because Mr. Berger is in violation of our zoning regulations. Mrs. Malott gave a letter from the County Recorder listing the fees for filing zoning resolutions and amendments. She said that there is a zoning commission meeting on January 26 at 7:00 p.m. She said that she plans to file the zoning changes with the County Recorder. Mr. Danbury motioned to approve filing the zone changes with the County Recorder. Mr. Henning second. All yeas. Mr. Henning said that he talked to Doug Chambers and he is interested in being a zoning commission member.

Mr. Henning said that he talked to Mayor Lefker about a joint township/village meeting and she was going to talk to the entire Village Council and then get back with him.

Mr. Danbury said that he received a phone call from our health insurance agent and he would like to come to our meeting on the 23<sup>rd</sup>.

Mr. Taylor motioned to adjourn at approximately 8:15 p.m. Mr. Danbury second. All yeas.
