

# The Williamsburg Township Board of Trustees

**August 22, 2005**

The Williamsburg Township Board of Trustees met on Monday August 22, 2005 to transact business. Chairman Danbury called the meeting to order at 7:30 PM, and all joined in the Pledge of Allegiance to the Flag. James Danbury, Bari Henning and Jim Taylor answered the roll call. Also present were Clerk, Gregory W. Carson, Yvonne Malott, Deputy John Schaeffer and Earl Whiteman.

Mr. Henning motioned to approve the minutes of the last meeting. Mr. Taylor second. All yeas. Mr. Carson presented a financial report, including a comprehensive account of expenditures and receipts and the trustees accepted it.

### **Cemetery & Maintenance Report**

Mr. Whiteman said that the pipe on Todds Run Road is rusted out and the cost to replace it would be over \$2,600, plus track hoe rental and man hours. He said that it looks pretty bad and it's a really old pipe. He said that there was an automobile accident there that really damaged the pipe. He said that the State Highway Patrol is supposed to be faxing a copy of the police report. The trustees discussed whether or not to contact the automobile insurance company. Trustees agreed to get a copy of the report and to contact the insurance company. He said that all of the other pipes that they intended to replace this year are done. He said that all equipment is up and running. He said that all of the roads should be finished mowing by the time school starts this week. We received a letter from the County Engineer's office stating that Concord Hennings Mill Road will be closed for culvert replacement from 8/29/05 to 9/2/05.

### **Zoning Report**

Mrs. Malott presented a zoning report. Mr. Danbury. She said that Cincinnati Bell Yellow Pages had called to see if we wanted to advertise on their webpage for \$27.00/month and the trustees all said NO. Mr. Henning said that the grass was mowed and the car was taken away at a home on Bootjack Road and he wondered if she had contacted the owners. She said that she had contacted them.

### **Sheriff Report**

Deputy Schaeffer presented a list of the number of runs for July. He thanked the trustees for renewing the sheriff contract and said that he enjoys serving out township very much. He said that the number of runs were down slightly for July, because he was on vacation for two weeks. He said that he has had some domestic disputes off of Cain Run Road and he had to smooth things over. He said that he is aware of the speed limit reduction on the road and he is watching it more. Mr. Taylor asked if anyone had heard anything about the person on Alexander Lane who had a high frequency radio. Deputy Schaeffer said that he had contacted the FCC himself and had received no help. Mr. Danbury told him that the FCC had sent the owner a letter and we haven't heard anything from the neighbors recently. Deputy Schaeffer said that he will be in training in Alabama from 9/11/05 to 9/16/05.

Mr. Danbury said that there is a birthday celebration for Harmony Hill on Sunday, August 28, 2005. Mr. Danbury said that Paul Werring from Jackson Township called and said that they are willing to pay an additional \$10/run surcharge per run into their township until fuel comes back down below \$2.00/gallon. Mr. Taylor motioned to approve this fuel surcharge. Mr. Danbury second. All yeas.

Mr. Henning motioned to adjourn at approximately 8:25 p.m. Mr. Taylor second. All yeas.
