

Williamsburg Township Board of Trustees Minutes

October 28, 2019

The Williamsburg Township Board of Trustees met on Monday October 28, 2019 to transact business. Chairperson Bainum called the meeting to order at 7:00 PM, and all joined in the Pledge of Allegiance to the Flag. Guy Bainum, Bari Henning and Gary Jordan answered the roll call. Also present were Fiscal Officer, Gregory W. Carson, Ron Ayers, Ed Boll, Meghan Alley and Kevin Wiedemann.

Mr. Henning motioned to approve the minutes of the last meeting. Mr. Bainum second. All yeas. Mr. Carson presented a financial report, including a comprehensive account of expenditures and receipts and the trustees accepted it.

Mr. Jordan motioned to pay the attached bills. Mr. Henning second. All yeas.

Mr. Ayers said that they are still doing donuts with the cars on the airway strip. The trustees explained that a race track is not allowed, but a donut isn't a race track if it's on their private property.

Emergency Services Report

Mr. Wiedemann gave a copy of a proposed training form that he would like to implement with staff and volunteers. The trustees said that they think that the form looks good. Mr. Wiedemann gave a copy of specs for a new ambulance and asked what the trustees wanted to do. The trustees said that they need to review the budget #'s to see where we stand and when we can purchase a new one. Mr. Wiedemann said that one of our EMS workers filed a work related worker's comp claim in 2017, but worker's comp denied it. He said that he feels that it was clearly a work related injury, because a person vomited on them and it went into their eyes and so he sent them to Mercy to get checked out. This employee is now receiving an invoice from Mercy and Mercy is threatening collections. Mr. Jordan said that we should take care of the bill since it was an employee work related injury. Mr. Wiedemann said that the employee has checked with Worker's Comp and it's too late to appeal it. Mr. Jordan motioned to pay the invoice to Mercy for the employee. Mr. Bainum second. All yeas. Mr. Wiedemann asked if they could exchange Veteran's Day for the day after Thanksgiving as the holiday. The trustees agreed that it's OK for them to do this. Mr. Wiedemann gave a copy of the clothing allowances for the year and explained to the trustees who is allowed to get this and the criteria for who get the reimbursement.

Cemetery & Maintenance Report

Mr. Tatman sent a copy of his report in his absence. Mr. Jordan said that Shirley Fee is having water problems in her ditch and she asked the township to contact the county to have them do some work on her ditch. Mr. Bainum said that the speed camera is still on Hageman's Crossing and will be moved to Bootjack Road soon.

Zoning Report

Mr. Tatman sent a copy of his report in his absence. Mr. Bainum said that Mr. Tatman had met with the village regarding 390 East Main Street and the EPA asked them to resolve the problem locally instead of the EPA doing anything. Mr. Bainum said that we received notification from the County Commissioners that the properties along State Route 133 North to State Route 32 have been approved for annexation.

Mr. Bainum said that we had originally set November 12 as our next meeting date, but we have discovered some conflicts, so we are moving it to November 13 and will do proper notifications. Mr. Bainum reminded everyone that Thursday is Halloween trick or treat.

Mr. Henning motioned to adjourn at approximately 7:35 p.m. Mr. Bainum second. All yeas.
