

# Williamsburg Township Board of Trustees Minutes

## July 25, 2016

The Williamsburg Township Board of Trustees met on Monday July 25, 2016 to transact business. Chairman Bainum called the meeting to order at 7:00 PM, and all joined in the Pledge of Allegiance to the Flag. Guy Bainum and Bari Henning answered the roll call. Also present were Fiscal Officer, Gregory W. Carson, Kevin Wiedemann, Brian Tatman, Ed Boll, Yvonne Malott, Vince Faris and Ernie Ramos.

Mr. Henning motioned to approve the minutes of the last meeting. Mr. Bainum second. All yeas. Mr. Carson presented a financial report, including a comprehensive account of expenditures and receipts and the trustees accepted it.

Mr. Bainum motioned to pay the attached bills. Mr. Henning second. All yeas.

Mr. Bainum said that Mr. Jordan is out of town on business tonight. He apologized that the air conditioning is not working and we would be moving quickly through the meeting as it's over 80 degrees in here at the moment.

### Zoning Report

Mrs. Malott presented a zoning report. Mr. Henning said that the property on Bootjack Road had been mowed. She said that she has a letter to sign about nuisance grass and will be following the ORC for taking care of notification and bush hogging, etc. She said that she is working with the court and Sheriff still regarding the property on Old State Route 32 by WJAA and Duke Energy. She said that he had been served with a warrant on May 16 and didn't show. He was served another warrant in June and he didn't show up for court again. She said that she is leaving for vacation this week and Pat Rutherford would be checking messages in her absence.

### Emergency Services Report

Mr. Wiedemann said that he plans to take vacation for the rest of the week. He said that he picked up the new Chief's vehicle and is working on lettering, lights, etc.

### Cemetery & Maintenance Report

Mr. Tatman said that he has contacted another government about borrowing their boom mower and it's in heavy use, but we should be able to get it soon to do some of our high problem areas. Mr. Henning asked how long it takes to mow all of the roads with our current mower and Mr. Tatman said it takes between 60 and 80 hours to do a cycle. Mr. Tatman brought some prices of used boom mowers. Mr. Henning asked some questions about how much it would be used and he explained about 5-10 days in the spring and 5-10 days in the fall. Mr. Tatman said he talked to the John Deere dealer and Kubota dealer about our needs. He gave estimates of approximately \$80,000 for a new one. Mr. Henning said that we have an old 2001 tractor with a broken hours meter. Mr. Tatman said that a new one could be versatile and replace the old mower. Mr. Henning suggested getting further information and pricing.

Mr. Bainum motioned to adjourn at approximately 7:30 p.m. Mr. Henning second. All yeas.
