

# Williamsburg Township Board of Trustees Minutes

## November 9, 2009

The Williamsburg Township Board of Trustees met on Monday November 9, 2009 to transact business. Chairman Taylor called the special zoning hearing for ZC2-09 to order at 7:00 PM, and all joined in the Pledge of Allegiance to the Flag. Guy Bainum, Bari Henning and Jim Taylor answered the roll call. Also present were Fiscal Officer, Gregory W. Carson, Gary Jordan, Randy Daniels, Ed Boll, Yvonne Malott and Earl Whiteman.

Mr. Taylor said that ZC2-09 is a text amendment for article 8, section 811, which is a modification of conditional use and article 1, section 118, which is a definition. The trustees said that they have read the amendment and are in agreement with the change.

Mr. Taylor motioned to adopt the changes for ZC 2-09 as presented by Mrs. Malott. Mr. Henning second. All yeas.

Mr. Henning motioned to adjourn the zoning hearing at approximately 7:10 and to start the regular session. Mr. Taylor second. All yeas.

Mr. Henning motioned to approve the minutes of the last meeting. Mr. Taylor second. All yeas. Mr. Carson presented a financial report, including a comprehensive account of expenditures and receipts and the trustees accepted it.

Mr. Taylor motioned to pay the attached bills. Mr. Henning second. All yeas.

Mr. Taylor said that we should set meetings to review fire chief applications and we have to advertise per ORC. Mr. Taylor suggested November 16 and November 18 and November 24 at 7 p.m. each night.

### Zoning Report

Mrs. Malott presented a zoning report. She said that she had a zoning permit today and it was the first one in a few months. She said that she put a message on her voicemail that the zoning department would be closed until November 23, because she is having surgery tomorrow on her leg from her recent injury. She said that she will be able to check voicemail while off. She said that there were quite a few people at the zoning hearing the other night and the meeting went well. She said that several people thought the project would be a great idea.

### Cemetery & Maintenance Report

Mr. Whiteman said that he would like to stop the Village of Williamsburg from using our cemetery as a dumping ground. He said that they are dumping stumps, roots, etc. Mr. Taylor said that he told the Village to ask him if they could dump stuff. Mr. Whiteman said that they just started dumping and didn't ask. Mr. Whiteman said that they can use clean fill dirt any time, but he doesn't want junk. He said that all of the equipment is up and running.

Mr. Boll said that lots of junk has been dumped around his property and he reported it to the Sheriff's office. He said that he thinks some of it is in the right of way. Mr. Bainum suggested cleaning it up and putting it in our dumpsters.

Mr. Bainum motioned to adjourn at approximately 7:55 p.m. Mr. Henning second. All yeas.
