

# Williamsburg Township Board of Trustees Minutes

## July 22, 2019

The Williamsburg Township Board of Trustees met on Monday July 22, 2019 to transact business. Chairperson Bainum called the meeting to order at 7:00 PM, and all joined in the Pledge of Allegiance to the Flag. Guy Bainum, Bari Henning and Gary Jordan answered the roll call. Also present were Fiscal Officer, Gregory W. Carson, Brian Tatman, Meghan Alley, Ed Boll, Kevin Wiedemann, Ernie Ramos, Vince Faris, Dick Malott and Yvonne Malott.

Mr. Henning motioned to approve the minutes of the last meeting. Mr. Bainum second. All yeas. Mr. Carson presented a financial report, including a comprehensive account of expenditures and receipts and the trustees accepted it.

Mr. Jordan motioned to pay the attached bills. Mr. Henning second. All yeas.

### Zoning Report

Mrs. Malott presented a zoning report. Mr. Bainum said that he heard that Jay Johnston told anyone participating in the drag racing wasn't allowed to spin out on State Route 133 or he wouldn't allow them to come back. Mr. Bainum asked about Ken Holt's property and she said that he has 42 acres and wants to build a new house, but keep the old house and she said that he can build a new one if he divides the property. Mrs. Malott said that the flea problem at the township hall had come back and Deron Dean flea bombed the building and it looks like the problem is taken care of. Mrs. Malott said that the zoning hearing about the potential Family Dollar has been postponed but not rescheduled yet.

### Cemetery & Maintenance Report

Mr. Tatman said that a tree came down on Musgrove Road last Wednesday. He said that two of the residents (Kyle Boggs and another one) were very helpful for the entire time that they were cleaning up the property and wanted to thank them. He said that another tree fell on Henning's Mill Road last week and had to be taken care of. He said that he had to pull off all of the vents on the outside of the township hall so that Deron Dean could spray and they were all so brittle, he is replacing all of them with new vents. He said that he's figured out how to work the new radar gun and he'll put it up this week. Mr. Jordan said that there is a large washout on Musgrove Road and Mr. Tatman said that they noticed it last week and they will get it taken care of. Mr. Jordan said that the blacktop patch job on Musgrove Road is great.

### Emergency Services Report

Mr. Wiedemann said that 3 people want to attend the Ohio Firefighter's Association Conference from August 8-11 and the cost would be \$75 plus meals and it's located at Eastgate Mall and he said that there should only be a per diem meals for Friday and Saturday, because there is only 1 hour of class on Thursday and none on Sunday. Mr. Henning motioned to pay the registration fee and to reimburse meals. Mr. Bainum second. All yeas. Mr. Jordan would like the Chief to remind them that the requests must be presented to the Chief by the Friday before the meeting or it won't be considered in the future. He also asked the participants to provide a written summary of the conference to the trustees or to attend a meeting and provide a summary. Mr. Wiedemann said that Jay Johnston asked if we could provide a life squad for his events in the township and he would pay for them. Mr. Henning said that one of his concerns is that if we have a need for the backup squad then we would need to leave the event. Mr. Wiedemann said that he would talk to Mr. Johnston about that situation of needing the 2<sup>nd</sup> squad. Mr. Henning said that he attended the event last weekend to see how it was being ran and it looked like they are trying to provide a high-quality event and do it the right way to prevent problems.

Mr. Bainum said that we received another annexation from the village to be considered by the County Commissioners in September.

Mr. Bainum motioned to adjourn at approximately 7:35 p.m. Mr. Jordan second. All yeas.
