

# Williamsburg Township Board of Trustees Minutes

## November 23, 2020

The Williamsburg Township Board of Trustees met on Monday November 23, 2020 to transact business. Chairperson Henning called the meeting to order at 7:00 PM, and all joined in the Pledge of Allegiance to the Flag. Guy Bainum, Bari Henning and Gary Jordan answered the roll call. Also present were Fiscal Officer, Gregory W. Carson, Kevin Wiedemann and Dillon Arnett.

Mr. Jordan motioned to approve the minutes of the last meeting. Mr. Bainum second. All yeas. Mr. Carson presented a financial report, including a comprehensive account of expenditures and receipts and the trustees accepted it.

Mr. Bainum motioned to pay the attached bills. Mr. Jordan second. All yeas.

Mr. Henning said that Mr. Tatman isn't here, because he's not feeling well, but his doctor doesn't think it's COVID-19, but Mr. Henning asked him not to come to the meeting just in case. He said that Mr. Tatman turned in zoning and cemetery & maintenance reports. Mr. Bainum said that the property just past the WJAA fields on Old State Route 32 look horrible and zoning needs to talk to them about cleaning it up again. Mr. Jordan reminded everyone that there is a zoning commission meeting on December 2 at 7 p.m.

### Emergency Services Report

Mr. Wiedemann would like to recommend Cori Torbin to be a part time EMT. Mr. Henning motioned to hire Cori Torbin as a part time EMT with standard probationary period. Mr. Jordan second. All yeas. Mr. Wiedemann said that we currently have 78 active Covid-19 cases in Williamsburg Township and the area of Jackson Township that we cover for EMS. Mr. Jordan asked to refresh him on our protocol after transporting a Covid-19 patient and Mr. Wiedemann explained their procedures. Mr. Wiedemann said that he is frustrated with the county prosecutor for not responding to Mr. Carson's email regarding the fraudulent unemployment claim that was processed in his name with his social security #. Mr. Wiedemann said that he's been paying a personal attorney to help him figure out how deep the fraud is on his SSN. He said that he's paying for Life Lock to protect his credit. Mr. Jordan thinks that we should look at reimbursing him for this because the fraud was from Unemployment Bureau under Mr. Wiedemann's name and SSN.

Mr. Henning motioned to go into Executive Session per ORC 121.22 for the purpose of investigation of a complaint against a public employee or official at approximately 7:25. Mr. Bainum second. All yeas. Trustees returned from Executive Session at approximately 8:55 p.m.

Mr. Jordan motioned to adjourn at approximately 8:55 p.m. Mr. Bainum second. All yeas.
