

Williamsburg Township Board of Trustees Minutes

November 8, 2021

The Williamsburg Township Board of Trustees met on Monday November 8, 2021 to transact business. Chairperson Jordan called the meeting to order at 7:00 PM, and all joined in the Pledge of Allegiance to the Flag. Guy Bainum, Bari Henning and Gary Jordan answered the roll call. Also present were Fiscal Officer, Gregory W. Carson, Bobby Feimster, Dylan Arnett, Brian Tatman, Tom Obermeyer, Kevin Wiedemann and Ed Boll.

Mr. Henning motioned to approve the minutes of the last meeting. Mr. Bainum second. All yeas. Mr. Carson presented a financial report, including a comprehensive account of expenditures and receipts and the trustees accepted it.

Mr. Bainum motioned to pay the attached bills. Mr. Henning second. All yeas.

Mr. Obermeyer asked for an update on the noise at Clear Mountain Food Truck Park. Mr. Jordan said that we have received a draft of a noise resolution from the Prosecutor and the trustees are reading it and making suggestions for changes to the prosecutor and hope to approve it at a future meeting. Mr. Feimster asked some questions about the noise resolution and the trustees tried to explain the intent of the policy and said that they are reviewing the policy in details before approved.

Zoning Report

Mr. Tatman presented a zoning report. He gave a copy of the zoning board of appeals and zoning commission members to review to see who needs to be renewed and/or replaced. The trustees asked him to contact the members to see if they want to renew. Mr. Tatman said that Arbor Homes is probably going to attend our next meeting to give us an update and then they will be meeting with the Zoning Board to review the plans. The trustees discussed hiring an advisor to help us with the PUD since we don't have any PUDs in the township.

Cemetery & Maintenance Report

Mr. Tatman presented a report. He said that we've had 75 funerals so far this year and 12 in October. He gave a copy of the roads that the township is responsible for and the years that they were paved last. He is proposing Maple Road, Bass Road, North Ellis Road and Coon Avenue for 2022 which is just shy of 2 miles of roads. He said that we paved 1.78 miles this year. He said that he had repaired the ditches on Musgrove Road. He said that he plans to put up No Parking signs once they mark the utilities. He said that Eli Mann is going to apply for his temporary CDL permit after Thanksgiving. He said that the 2 temporary workers are here thru the end of November.

Emergency Services Report

Mr. Wiedemann gave a copy of the runs for October. He said that he would like to build a training prop for fire hoses and he can build it with pressure treated wood for about \$300. Mr. Bainum motioned to buy the pressure treated wood for \$300 to build the training prop. Mr. Henning second. All yeas. Mr. Wiedemann said that Mary Marshall is retiring at the end of the year after 41.5 years of service. The trustees thanked her for her years of service! The trustees thanked Mr. Wiedemann for his hard work on election day in opening and closing. Mr. Bainum said that the township association is having their meeting at the emergency services building next Thursday.

Mr. Henning motioned to adjourn at approximately 8:00 p.m. Mr. Bainum second. All yeas.
