LEGAL NOTICE

The Board of Trustees of Williamsburg Township, Clermont County, Ohio, met in regular session on the 12th day of February, 2024 with the following members present:

Mr. Jordan moved for the adoption of the following Resolution No. 2024-03:

WHEREAS, the Township is authorized by Ohio Revised Code §505.17 to make such regulations as are necessary to control vehicle parking in the unincorporated area of the Township; and

WHEREAS, this Board determines that vehicle parking regulations are necessary to promote public safety in the unincorporated area of the Township; and

WHEREAS, it is in the best interest of the Township and its residents to designate additional no parking areas and to enact regulations for the enforcement of the parking restrictions on Afton Drive, West Fork Ridge Drive, East Fork Valley Drive, East Fork Hills Drive, and Rhodes Drive;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Williamsburg Township, Clermont County, Ohio with at least two-thirds of its members thereto concurring as follows:

- **Section 1**. Parking shall be prohibited on both sides of Afton Drive beginning at Half-Acre Road and ending at a point 500 feet southeast, a total length of .0947 miles or 500 feet.
- **Section 2**. Parking shall be prohibited on West Fork Ridge Drive.
- **Section 3**. Parking shall be prohibited on East Fork Valley Drive.
- **Section 4**. Parking shall be prohibited on East Fork Hills Drive.
- **Section 5**. Parking shall be prohibited on Rhodes Drive.
- **Section 6**. The Fiscal Officer is hereby directed to post notice of this resolution in five conspicuous places within the township for thirty days before the subject parking prohibitions become effective.

Section 7. Notice of this resolution shall be published in a newspaper of general circulation in the township for three consecutive weeks or as provided in Section 7.16 of the Ohio Revised Code.

Section 8. Once required notice is given, signs in compliance with the "Ohio Manual of Uniform Traffic Control Devices for Streets and Highways" shall be erected designating the subject sections of Afton Drive, West Fork Ridge Drive, East Fork Valley Drive, East Fork Hills Drive, and Rhodes Drive as no parking zones.

Section 9. The Fiscal Officer is hereby directed to provide a copy of this Resolution to the Clermont County Sheriff.
